WORKSHOP: PAS AS A WITNESS - THE BASICS OF DEPOSITION/TRIAL TESTIMONY FOR A DEFENDANT, EXPERT, OR NON-PARTY TREATER (2 CME)

In this workshop PAs will learn the 3 main scenarios in which they might be asked to give deposition or trial testimony in their professional capacity - as a defendant in a malpractice case, as a treating healthcare provider in a civil case, and as an expert in a civil case. PAs will learn the basics of preparing for testimony in these scenarios, including what types of questions to expect and how to deal with different scenarios. We will also practice answering questions as a defendant, treater, and expert.

WORKSHOP: PEDIATRIC DERMATOLOGY (2 SA-CME)

The Ultrasound-Guided Procedures for the Primary Care PA workshop introduces learners to integrating ultrasound use with common bedside procedures they may encounter in the clinic. Learners will receive guided simulation training for common bedside procedures, including cyst/ganglion/abscess aspiration, foreign body identification, large joint arthrocentesis/injection, tendon/muscle injection. Attendees will participate in a brief didactic session followed by scanning on models, and procedure simulation with manikins. This workshop is designed for those who wish to incorporate real-time ultrasound into their procedural skills. A background in ultrasound use is encouraged, but not required.
